Under the Health and Safety at Work Act, a fine of £200,000 was levied against

Kent County Council for oversight issues. The Court found that as the employer it had not ensured employees liable to be exposed to asbestos had been trained adequately During a routine EHO officer food inspection they found asbestos rope hanging from the school's kitchen ceiling.

An investigation by the HSE found that the school's caretaker, on the apparent instructions of the then headteacher, had disturbed an asbestos flue pipe and an asbestos rope gasket while removing an air steriliser in May 2013 to make way for a freezer.

The HSE served a prohibition notice, closing the kitchen. The notice said: "You have failed to prevent the exposure of employees to asbestos so far as reasonably practicable, in particular the partial steriliser flue and sealant in the school kitchen.' It was reported that neither the caretaker nor the headteacher had any asbestos management or awareness training. Though the council did have policies on providing asbestos training, it had failed to check and monitor that they were being properly followed. Kent pleaded guilty to breaching reg 10(1) of the Control of Asbestos Regulations.

Due to the council's early guilty plea, the judge awarded a full discount reflected in the fine of £200,000 with full costs of £21,501 to be paid. The guidelines allow for £400,000 but it was acknowledge that it
